

**FIRST AMENDMENT TO THE BYLAWS OF
IRON HORSE CANYON HOMEOWNERS ASSOCIATION, INC.**

The Bylaws for Iron Horse Canyon Homeowners Association, Inc. (hereinafter "the Bylaws"), are hereby amended as follows:

I.

Article III, Section 6 of the Bylaws is amended to read as follows:

6. Proxies. At all meetings of the Members each Member may vote in person or by written proxy. All proxies shall be in writing and filed with the Secretary. Every proxy shall be revocable and shall automatically cease upon conveyance by the Member of his Lot. No form of proxy may be used other than the official form issued by the Association, and photocopied duplications thereof, shall be valid.

II.

Article XV, Section 1 of the Bylaws is amended to read as follows:

1. These By-Laws may be amended at a regular or special meeting of the Members by a vote of a majority of all votes of the Association.

III.

Except as stated above, the Bylaws remain unchanged and are ratified and carried forward in full force and effect.

The foregoing First Amendment was adopted by the Board of Directors of Iron Horse Canyon Homeowners Association, Inc., pursuant to the authority in Section 22.102(c), Texas Business Organizations Code, as reflected by the signatures below of the President and Secretary of Iron Horse Canyon Homeowners Association, Inc.

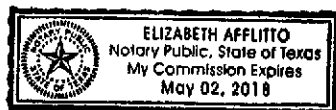

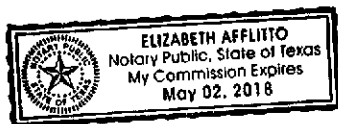
